

#### MADEIRA ATHLETIC BOOSTERS (MAB) MEETING MINUTES March 13, 2023

#### 1. Call to Order

Pete Seremetis (President) called to order the Executive Board and Select Committee meeting of the Madeira Athletic Boosters Association (MAB) at 6:35 PM on Monday March 13, 2023, at Perin Learning Commons at Madeira High School.

#### 2. Agenda and Approval of Minutes

Pete Seremetis (President) asked if members had any changes, questions, or comments to the minutes from the January 9, 2023 MAB meeting, Pete Seremetis (President) moved motion, seconded by Josh Fendley (Vice President) to approve minutes. All were in favor.

#### 3. New Business

- a. Athletic Funding Requests
  - i. Pete Seremetis (President) proposed motion, seconded by Josh Fendley (Vice President), to provide \$1,700 to Amazons Softball & Mustang Baseball for training equipment. All were in favor.
  - ii. Pete Seremetis (President) proposed motion, seconded by Josh Fendley (Vice President), to provide \$3,000 to Madeira Athletic Department for January operational expenses (request includes Football helmets). All were in favor.
  - iii. Pete Seremetis (President) proposed motion, seconded by Josh Fendley (Vice President), to provide \$6,000 to Madeira Athletic Department for February operational expenses (request includes hotel accommodation for Swim team at State Tournament, Lacrosse helmets, and a Chair Rack). All were in favor.
  - iv. Pete Seremetis (President) proposed motion, seconded by Josh Fendley (Vice President), to provide \$650 to Madeira Swim Team for State recognition. All were in favor.
  - v. Pete Seremetis (President) proposed motion, seconded by Josh Fendley (Vice President), to provide \$73,500 to Madeira Athletic Department for replacement floor in MHS Back Gym. All were in favor.
- b. Automated External Defibrillator (AED)
  - i. Joe Kimling (Athletic Director) confirmed that all Madeira coaches are trained in use of AEDs and are aware of their locations on school campus.
  - ii. Multiple requests to communicate to broader school community where AEDs are positioned. For example, few are aware of the AED located by Softball field. An informational message will be sent to all Student Athlete families via Final Forms.

  - i. Amy Benetti/MSA Design and Kenji Matsudo, Superintendent reviewed potential scenarios for updating Madeira school district athletic facilities. To maximize cost efficiency, project scope



includes academic classroom space and additional Science Labs for MHS. Facility updates will be carefully planned in multiyear phases to maximize return on investment and benefit to Madeira students and community stakeholders. Detailed plans and timelines are being developed.

- ii. One winner returned funds to MAB so net proceeds are \$4,000.

  - c. The Wrestling Team won the CHL as well as the Sectional Tournament
  - d. Girls Swim Sectional Champions
  - e. 3 CHL Coach of the year winners:

    - ii. Chris Davidson Wrestling
    - iii. Chip Dobson Girls Swim
  - f. 8 Wrestlers qualified for Districts
  - g. 14 Swimmers qualified for State
  - h. A number of other post season awards for all teams.
- 2. The HVAC project will begin in Mid April- We have planned the summer gym shut down and we are working with coaches to make sure we have a plan for gym space.
- 3. The Spring Teams have been working hard to get ready for the season. We have a full slate of scrimmages starting this week.
- 4. Team Photos for HS teams will take place tomorrow.
- 5. Pending a vote by the board of control the CHL AD's have voted to increase the Official's Fee Schedule for 2023-2025. The Admissions committee has not come back with a recommendation for an admission increase, but I do expect to see a recommendation for an increase.
