

### MADEIRA ATHLETIC BOOSTERS (MAB) MEETING MINUTES February 12, 2024

#### 1. Call to Order

Pete Seremetis (President) called to order the Executive Board and Select Committee meeting of the Madeira Athletic Boosters Association (MAB) at 6:30 PM on Monday January 8, 2024 at Teachers conference room at Madeira High School.
